Proceedings of the preparatory meeting on election of members to the Committees of Primary Societies held on 15.03.2022 at 3.30PM in the Conference Hall of Odisha State Agricultural Marketing Board, Bhubaneswar.

A preparatory meeting on election of members to the Committees of Primary Co-operative Societies was held on 15.03.2022 at 3.30PM in the Conference Hall of Odisha State Agricultural Marketing Board, Bhubaneswar. The meeting was presided over by Sri Sundaralal Seal (IAS Retd.), State Cooperative Election Commissioner.

The Deputy Registrar of Co-operative Societies who are designated as District Co-operative Election Officers-cum-District coordinating Officers in respect of Cuttack/Cuttack-II/Khordha/Puri/Berhampur /Balasore and Sundergarh District and CEOs of Urban Bank and other Credit Societies were present in the meeting. At the outset, the Secretary welcomed all the participants and requested all to offer their self introduction. Then Secretary sought cooperation of all the Officers for forthcoming Co-operative election.

Then, a threadbare discussion was made on the agenda points and following decisions are taken.

Agenda No.1 Status on the updation of Membership list.

All the DCEOs are instructed to ensure for updation of the membership register of Urban Co-operative Banks as well as Credit Co-operative Societies functioning under their jurisdiction and a soft copy is to be submitted to this Commission within 3 days time .

Agenda No.2 Requirement of Ballot Boxes and indelible ink

All the CEOs are instructed to procure requisite Ballot Box (i.e.1 Ballot Box for 1000 no .of Voters) for Booth and place the indent of indelible ink in respect of Urban Bank and other credit Co-operative well in advance .

Agenda No.3 Deployment of Election officers, Presiding Officers, Polling Officer & their appointment

It was suggested to deploy Sub-collector/Additional District Magistrate as Election Officer in respect of some Urban Bank for smooth conduct of Election. In this regard DCOs are instructed to furnish a proposal within three days.

Agenda No.5 Location of Polling Station

As the membership position of Urban Bank is more than 5,000 thousand, there is a need of School or College Building having adequate space for polling station. In this regard DCOs are instructed to contact the Collector and District Magistrate for finalization of Polling station well in advance.

Agenda No.6 Constitution of Election Cell

All the CEOs are instructed to furnish the Name and Contact no. of the Election Cell In Charge within three days.























The Commissioner instructed all the DCOs/CEOs of Urban Bank and other Credit Societies to complete the activities within the time limit fixed by this Commission.
