Proceedings of the preparatory meeting on election of members to the Committees of Primary Societies held on 09.03.2022 at 11 AM in the Conference Hall of Odisha State Agricultural Marketing Board, Bhubaneswar.

A preparatory meeting on election of members to the Committees of Primary Co-operative Societies was held on 09.03.2022 at 11 AM in the Conference Hall of Odisha State Agricultural Marketing Board, Bhubaneswar. The meeting was presided over by Sri Sundarlal Seal (IAS Retd.), State Cooperative Election Commissioner.

The Deputy Registrar of Co-operative Societies who are designated as District Co-operative Election Officers-cum-District Co-ordinating Officers in respect of Khordha, Puri,Nayagarh,Cuttack,Angul, Dhenkanal District and District Co-operative Election Officers of other Departments were present in the meeting. The attendance is attached at Annexure-A.

At the outset, the Secretary welcomed all the participants and requested all to offer their self introduction. Then Secretary sought cooperation of all the Officers for forthcoming Co-operative election. Apart from that, Secretary explained regarding the new step taken by the Commission on filing of grievance by the members in online mode during the election period through our new website i.e scec.odisha.gov.in.

After that Secretary requested the Commission to offer his views for smooth conduct of Co-operative election. Commissioner requested the DCEOs of respective Department to take note of the following points.

- a. Constitution of Election Cells in all the DCEOs and in the office of the Assistant Registrar of CS and submission of the report within three days time.
- b. Submission of the list of Master Trainers within three days time. After receipt of the same they will be imparted training at state level shortly.
- c. Preparation of Master Plans of Election by the DCEOs by end of this month.
- d. Location of Polling Station is to be finalized and it is to be reflected in the Master Plan.
- e. Assessment of Sensitive and Supersensitive Booths and it is to be reflected in the Master Plan.
- f. Meeting with the Collector and District Magistrate and collection of list of Election Officers and submission of the list to the Commission by 21`.03.2022.
- g. Procurement of Ballot Boxes by the Societies under the supervision of DCEOs.
- h. Regular visit of State Co-operative Election Commission's website(i.e.scec.odisha.gov.in)

Then, a threadbare discussion was made on the agenda points and following decisions are taken.

Agenda No.1 List of Primary Cooperative Societies due for Election& their postal address.

As per the report received by this Commission 3071, Primary Co-operative Societies of Khordha, Puri,Nayagarh,Cuttack,Angul and Dhenkanal are due for Election. But during the discussion it has come to the notice that the figures need some compilation before issue of notification. In this regard all the DCEOS are requested to furnish the revised figures within seven days positively. However the figure available at this Commission is attached for reference.(Annexure-B)

Agenda No.2 Preparation of Membership list of the Societies.

During the discussion the representative of OMFED wanted to know whether the enrollment of membership in the Societies is ceased or not. The matter was clarified that enrollment of members can be done till the publication of notification for election. Further, all the DCEOs are instructed to update the membership register with proper verification by the concerned officials in conformity with the Bye law to make the election free and fair and a compliance report in this regard is to the furnished to the Commission within seven days. The Copy of the same is attached for reference.(Annexure-C)

Agenda No.3 Deployment of Election officers, Presiding Officers, Polling Officer & their appointment.

All the DCEOs expressed that there is shortage of manpower with them. In this regard, the Deputy Registrar of Co-operative Societies-Cum-DCOs have been advised to convene a meeting under the Chairmanship of the District Collector along with all DCEOs of other Department for obtaining the requisite number of Election officers as per the Notification no.1106 dt 27.10.2014 and Notification No.1201 dtd 07.11.2014 issued earlier by this Commission.

Agenda No.4 Submission of list of Master Trainers for training at State Level

Trainings will be conducted at the State level for the Master Trainers in order to educate them with regard to the Co-operative election rules,1992 and OCS, Act 1962. These Master Trainers will impart training to the Election Officers and other Polling Officers at Division/District/Circle level. In this context all the DCEOs are instructed to furnish the list of Master trainers within **three days** positively.

Agenda No.5 Location of Polling Station

In case of non availability of suitable premises of the Primary Co-operative Societies for conduct of election nearby public institutions like School Buildings, Panchayat Buildings, Community Centre etc are to be indentified for Polling stations.

In this regard, all DCEOs are directed to obtain the prior approval from the competent authority well in advance.

Agenda No.6 Constitution of Election Cell

All the DCEOs are directed to constitute Election Cells in the office of the DCEOs and other offices in order to resolve the election related issues as well as to carry out the instructions of this Commission within the time limit and the compliance report is to be submitted within three days positively.

Agenda No.7 Requirement of Ballot Boxes

The report on availability of Ballot Boxes as received by this Commission is attached(Annexure-D). Further all the DCEOS are directed to procure the Ballot Boxes as per the proceeding communicated vide this office Letter no. 135 dt 19.1.2022.

Agenda No.8 Assessment of Sensitive and Super Sensitive Booths

All the DCEOs are instructed to assess the Sensitive and Super Sensitive Booth well in advance in order to maintain law and order during election. Apart from that it needs to be reflected in the Master Plan of the District.

Agenda No.9 Discussion on new Website & Online Grievance Management system

A new website of State Co-operative Election Commission (i.e scec.odisha.gov.in) was launched on 18.01.2022. There is also provision for filing of online grievance by the members of the Society relating election matter. The DCEOs have been advised to visit the website on regular basis.

Agenda No.10 Other matters with permission of the chair

The Commissioner instructed all the DCEOs to complete the activities relating to election work within specified time limit fixed by this Commission.
