ORDER

In supersession to previous orders and in pursuance to Rule 22 of OCS (Elections to the Committees) Rules, 1992 the Presiding Officer may employ at the polling station such persons as he thinks fit to help in identification of voters to assist him otherwise, in conducting the poll.

Now, therefore, in exercise of powers vested with the State Cooperative Election Commission under Section 28AA (1) of OCS Act,1962, it is hereby directed that each voter whose name finds place in the final electoral roll of the Society may produce any one of the following documents in support of his or her identity at the time of polling.

- 1. Kishan Credit Card.
- 2. Voter Identity Card issued by Election Commission of India
- 3. Passport
- 4. Driving license
- 5. Pan card.
- 6. Aadhar Card
- 7. Bank/ Post office Passbook with photograph
- 8. Ration card / BPL Card
- 9. MGNREGA Job Card
- 10.Freedom Fighter Identity Card
- 11.Ex-service men's widow/ Dependent certificate
- 12.Green Card.
- 13. Pension document with photograph
- 14. Certificate of disability

- 15. Service identity card issued by State/Central Government Public SectorUndertaking, Local bodies or other Private Sector Organization
- 16.SC/ST /OBC/SEBC certificate issued by competent Government Authority.
- 17. Property document such as Land Pass Book, Registered Deed.
- 18. Railways/ Bus pass.
- 19. Student Identity Card (in case of student Cooperative Societies only)
- 20. Any other documentary evidence establishing the identity of the voters to the satisfaction of the Presiding Officers.

However, non production of identity proof as specified above shall not disentitle a voter from exercising his/her right of voting if his/her identity is proved otherwise.
