MINUTES OF THE PREPARATORY MEETING ON ELECTION TO THE CO-OPERATIVE SOCIETIES HELD UNDER THE CHAIRMANSHIP OF CHIEF SECRETARY, ODISHA IN THE CONFERENCE HALL OF LOK SEVA BHAVAN ON 22.03.2022 AT 11.00 A.M.

On the request of the State Co-operative Election Commissioner, Odisha, a Preparatory meeting was held under the Chairmanship of Chief Secretary, Odish regarding preparation for conducting Co-operative Election in the State. The list of Officers present in the meeting is given at Annexure-I.

At the outset, Principal Secretary, Cooperation, Department apprised that the State Co-operative Election Commissioner, Odisha is going to conduct election to 7076 Primary Societies , 132 Central Societies and 21 Apex Societies in the State . The State Co-operative Election Commissioner, apprised that a detailed exercise has been done by the Commission to conduct elections of the Co-operative institutions in two phases keeping in view the availability of the manpower and statutory requirement of Act & Rules. It was decided that manpower from other Departments will be mobilized in order to conduct the Phases-I election in respect of Primary Co-operative Societies on two poll dates.

After a detailed discussion on various issues concerning the conduct of the elections to the Co-operative institutions and taking into account the process of conducting Co-operative elections in the State the following decisions were taken.

1. Notification for Election of Primary Co-operative Societies.

The Government will issue Gazette Notification calling upon the Co-operative Societies to elect the members of the Committee of the Societies i.e, Primary, Central & Apex Societies functioning under the Cooperation Department as well as other Department as per the recommendation of the State Co-operative Election Commission, Odisha.

2. Issue of directions to all concerned Departments to follow the instruction of SCEC

Instruction will be issued to all concerned Departments as well as District Collectors to make all requisite arrangements as directed by the State Co-operative Election Commissioner for conduct of elections.

Instruction will be issued by the Chief Secretary, Odisha to the concerned Department and the Collectors that the personnel appointed for election duty are not disturbed from their place of posting during the election period. In case of non-availability of District Level Officers to act as District Co-operative Election Officers (DCEOs) the Collectors will ensure that other officers are entrusted with such duties for smooth conduct of election.

The Cooperation Department will provide experience staff to the SCEC as per the proposal submitted by the Commission.

3. Appointment of Election Officers & Polling Personnel

As per Gazette Notification No.1106 dtd.27.10.2014 & No.1201 dtd.07.11.2014 of State Co-operative Election Commission SARCS, ICS, CEOs, SAAGCS & ACS of Cooperation Department, PEOs of Panchayati Raj Department, VAWs of Agriculture & Farmers Empowerment Department, SARCS (Textiles), Inspector of Textiles, Weaving & Production Supervisors, Technical Inspector & Senior Tassar Assistants of Handlooms, Textiles & Handcrafts Department, BVOs, Addl. FOs, AFOs, SARCS (Fisheries), Inspector of Fisheries, SFTA. Live Stock Inspector (LIs), Assistant Manager, Junior Manager & Supervisors (OMFED) of Fisheries & Animal Resources Development Department, General Manager & Assistant Manager of ST & SC Development & Minorities and Backward Classes Welfare Department, IPOs, Industrial Supervisors (K&VI), Coir Supervisors, General Managers (DIC), Assistant Manager (DIC), S.O., Assistant (MSME) of Micro Small & Medium Enterprises Department have been designated as Election Officers.

In addition to the previous Notifications additional personnel from other departments likes, Handcraft Promotion Officers (HPO) of Handlooms, Textiles & Handcrafts Department and Junior Fisheries Technical Assistants (JFTA) of Fisheries and Animal Resources Development Department will be notified as Election Officers.

The Collector and District Magistrates are to ensure that the list of required number of Election Officers are placed with the State Co-operative Election Commission by 31.03.2022. In this regard the Divisional DRCS/ARCS of the Circles will coordinate the matter with their respective district Collector.

In the last election, few ADM and Sub-Collectors were engaged as the Election Officers for societies like Central Co-operative Banks, Urban Co-operative Banks etc. This time also Collectors may place their services with the Commission as per the requisition of the District Co-operative Election Officers (DCEOs).

4. Appointment of Nodal Officer

It was decided that Directors of the concerned Departments will act as State Level Nodal Officers for conduct of elections to the co-operative institutions under the fold of their respective Departments. Registrar, Co-operative Societies, Odisha will function as the State Level Coordinator for Nodal Officers to facilitate smooth conduct of the co-operative elections in the entire State as per the direction of the Commission.

The District Level Officers of the concerned Departments will function as the District Co-operative Election Officer –cum-District Level Nodal Officers for co-operative institutions under the fold of the respective Department and DRCS will function as the District Coordinating Officer for conduct of the co-operative elections in the entire district.

5. Procurement of Ballot Boxes & Other Election Materials

It is decided that the DCEOs will assess the actual requirement of Ballot Boxes and ascertain availability of the same from the District Administration. This is to be communicated to the State Co-operative Election Commission, who in turn will move the State Election Commission for provisioning of the same. In case of any shortfall the PACS/LAMPSCS will procure the requisite Ballot Boxes.

6. Budget for Co-operative Election and payment of Remuneration and Honorarium

The budget proposal submitted by the Commission for conduct of election may be approved by the Finance Department without reducing the funds in major heads. The diversion of funds from one head to another head as proposed by the Commission may be approved quickly. The funds under the head “Law & Order Arrangement” amounting to Rs. One Crore will be placed with DG, Police. The DG, Police will allocated the funds to the SPs as per number of societies in their districts and not uniformly.

There is provision for payment of remuneration/ Honorarium to the Election Officers & others but their TA/DA shall be borne by the concerned Department / Institutions. The funds towards Remuneration, Honorarium, hiring of vehicles for monitoring & supervision of election works and training expenses at the district/Sub-divisional level shall be placed to the DRCS-cum-DCEOs through Registrar of Co-operative Societies, Odisha.

7. Law and Order Arrangement.

Adequate Police arrangement will be made for Sensitive and Supersensitive Polling Stations by the Superintendent of Police of the district. The District Collector, Superintendent of Police of the District and the District Co-operative Election Officers (DCEOs) will finalize the list of sensitive and Supersensitive Polling Stations.

8. Polling Stations.

In case of non-availability of suitable office premises in the Society for conduct of election, nearby School buildings / College building will be utilized as polling stations. The School & Mass Education Department & Higher Education Department have to issue an order in this regard.

9. Compensation to Personnel on Election duty in case of causalities / accidents

Since there is no provision under OCS Act & Rules for payment of any ex-gratia /compensation in case of any accidents/ causality of officers on election duty, it is decided that any such cases are to be covered under CMRF. The Cooperation Department have to move the file accordingly for taking necessary approval of the Government.

The district administration will ensure that all the Election Personnel are given Booster dose of COVID-19 vaccine before Co-operative Election.

These issues with the approval of Chief Secretary, Odisha.

Sub: Election to the Co-operative Societies in the State.

Sir/ Madam,

As you are aware steps are being taken by the State Co-operative Election Commission to conduct election to the Co-operative Societies in accordance with the provisions of Odisha Co-operative Societies Act, 1962 and the rules framed there under, the concerned Department are expected to make requisite arrangements as directed by the State Co-operative Election Commissioner for smooth conduct of elections. In this regard, a meeting was held on 22.03.2022 in which following important decisions were taken.

1. The service of personnel as requisitioned by the State Co-operative Election Commission will be placed at the disposal of the Commission by the respective Collectors. This work will be coordinated by the DRCS-cum-District Coordinating Officers of the respective districts at the district level and appointment of Election

Officers, Presiding Officers and Polling Officers will be done as directed by the State Co-operative Election Commission.

The Director of the concerned Department should instruct their DECOs to get the list of Election Officers from concerned DRCS/ Collectors from the district and ensure that the appointment orders are issued as per dateline fixed by the Commission.

2. Directors of the concerned Departments will act as State Level Nodal Officers for conduct of elections to the co-operative institutions under the fold of the respective Departments. Registrar, Co-operative Societies, Odisha will function as the State Level Coordinator for Nodal Officers to facilitate smooth conduct of the elections to the Co-operative Societies in the entire State as per the direction of the Commission.

The Directors of the concerned Departments are also instructed to attend the meeting and training organized by the State Co-operative Election Commission. They should provide information to the Commission as and when required.

3. The District Level Officers of the concerned Departments will function as the District Level Nodal Officers for co-operative institutions under the fold of the respective Departments and DRCS will function as the District Level Coordinator for conduct of the co-operative election in the entire district.

4. BDOs will function as Block Level Nodal Officer for conduct of election to the co-operative institutions within their Block including the urban areas falling within the territorial boundary of the respective Block.

5. Adequate police arrangement will be made for Sensitive and Supersensitive Polling Station by the Superintendent of police of the district. The District Collector, Superintendent of police of the District and the District Co-operative Election Officers (DCEOs) will finalise the list of sensitive and Supersensitive Polling Station.

6. The DCEOs will assess the actual requirement of Ballot Boxes and ascertain availability of the same from the District Administration. This is to be communicated to the State Co-operative Election Commission, who in turn will move the State Election Commission for provisioning of the same. In case of any shortfall the PACS/LAMPCS will procure the requisite Ballot Boxes.

7. In case of non-availability of suitable office premises in the Society for conduct of election, nearby school building will be utilized as polling stations. The school & Mass

Education Department & Higher Education Department have to issue an order in this regard.

8. The training at various levels will be conducted as per the programme of the State Co-operative Election Commission. After the training is over, DCEOs will ensure that the Election Officer issue notice for conduct of elections, as per direction of the State Co-operative Election Commission, keeping in view the statutory period of 60 days as per provisions of the Act and Rules.

9. There is provision for payment of remuneration /Honorarium to the Election Officers & others, but their TA/DA shall be borne by the concerned Departments/Institution. The TA/DA of the employees of the Co-operative Societies will be by the respective Societies.

10. The field officers who are designated as the District Co-operative Election Officers, Election Officers & other Polling Officers should not be transferred during election process.

You are requested to take necessary action accordingly and issue instructions to all concerned officers under your control to extend the requisite support in order to facilitate conduct of the election to the Co-operative Societies in the State as per the direction of the State Co-operative Election Commission, Odisha.

As you are aware the State Co-operative Election Commission has already initiated the preparatory works to conduct elections to the Co-operative Societies in the State. In this regard, a Co-ordination meeting was held with the State Co-operative Election Commission on 22.03.2022 where the following decisions were taken.

1. The services of personnel to be appointed as Election Officers as per Gazette Notification No.1106 dtd.27.10.2014 & No.1201 dtd.07.11.2014 of State Co-operative Election Commission will be placed at the disposal of the District Co-operative Election Officers (DCEOs) by the respective District Collectors by 31.03.2022 for their appointment & training . This work will be coordinated by the DRCS-cum-District Coordinating Officers (DCEOs) of the respective districts at the district level and appointment of Election Officers will be done as directed by State Co-operative Election Commission.
2. As per the above Notifications, the Secretary and other employees of the Co-operative Societies will be deployed as Presiding Officers and Polling Officers under the direction of the State Co-operative Election Commission. 3. The District Level Officers of the concerned Departments will function as the District Co-operative Election Officer-cum-District Level Nodal Officers for Co-operative Institutions under the fold of the respective Department and DRCS will function as the District Coordinating Officer for conduct of the co-operative elections in the entire district.
4. The services of BDOs, Tahasildars, Sub-Collectors and ADMS are also to be utilized for smooth conduct of election.
5. The training at various will be conducted as per the programme of the State Co-operative Election Commission. After the training is over, DCEOs will ensure that the Election Officers issue notice for conduct of elections, as per direction of the State Co-operative Election Commission, keeping in view the statutory period of 60 days as per provisions of the OCS Act and Rules.
6. The DCEOs will assess the actual requirement of Ballot Boxes and ascertain availability of the same from the District Administration. This is to be communicated to the State Co-operative Election Commission, who in turn will move the State Election Commission for provisioning of the same. In case of any shortfall the PACS/LAMPCS will procure the requisite ballot boxes.
7. There is provision for payment of remuneration/ Honorarium to the Election Officers & other but their TA/DA shall be borne by the concerned Departments / Institutions. The TA/DA of employees of the Co-operative Societies will be borne by the respective Societies.
8. Adequate Police arrangement will be made for Sensitive and Supersensitive Polling Station by the Superintendent of Police of the District. The District Collector, Superintendent of Police of the District and the District Co-operative Election Officers (DCEOs) will finalize the list of sensitive and Superintendent Polling Stations.
9. In case of non-availability of suitable office premises in the Society for conduct of election, nearby School Buildings / College Buildings will be utilized as polling stations. The list of such School & College buildings will be placed by the DRCS-cum- DCEOs to the Collector for necessary permission at district level.

Sir/Madam,

In inviting a reference to the subject cited above, I am directed to say that as per Government Notification No.658/Coop dtd. 04.04.2022 the election to 7076 Primary Co-operative Societies of the State will be held on two poll dates i.e. on 19.06.2022 & 26.06.2022. After completion of 1st phase election of Primary Co-operative Societies, the 2nd phase election for 132 nos. of Central Co-operative Societies of the State will be held during October 2022 and after completion of this phase, the 3rd phase of 21 Apex Co-operative Societies of the State will be held in the month of January, 2023. All the Apex Societies are functioning within the jurisdiction of Bhubaneswar Municipal Corporation.

The DRCS, ARCS and District Level Officers of other departments like Handlooms, Textiles and Handicrafts, Fisheries and Animal Resources Development, MSME (Industries) etc. are functioning as District Co-operative Election Officers (DCEOs). The training of the DCEOs and Master Trainers have been conducted at State level on 29th, 30th & 31st March, 2022. Subsequently, the training for Election Officers for Primary Co-operative Societies have been conducted in 58 ARCS circles of the State in different dates from 06.04.2022 to 13.04.2022.

As per statute, the Election Officer has to take up all the statutory works beginning from notifying the date of election for the Co-operative Society at least two months prior to the date of poll till completion of the election of President & Vice President of the Society.

For conduct of the poll adequate number of ballot boxes are not available with the concerned departments. The requirement of ballot boxes in the district in respect of all the Co-operative Societies of different departments will be assessed by the DRCS-cum-District Coordinating Officers (DCOs) and the requirement of additional Ballot Boxes shall be placed with the District Administration.

The District Co-operative Election Officer-cum-Nodal Officers of the concerned departments have been instructed to procure the election materials like indelible ink, forms, ballot paper, electoral roll etc. at their level by pulling funds from the Co-operative Societies centrally through concerned Central Co-operative Banks. As per sub-section 8 of Section 28-A of OCS Act, 1962 all the election expenses have to be borne by the Societies concerned.

Some of the Co-operative Societies do not have suitable office building to be used as Polling Station and as such the school buildings of Primary Schools / High Schools & Higher Secondary Schools (Junior Colleges) are to be used as Polling Station in those areas. The School & Mass Education Department have been requested vide Commission's letter No.690 dtd.06.04.2022 to accord necessary permission for use of school buildings for use as Polling Stations.

The Commissionerate of Police, Bhubaneswar-Cuttack and all the Superintendents of Police have been requested vide Commission's letter No.840 dtd.13.04.2022 to provide necessary police assistance as and when requested by the District Co-operative Election Officers / Election Officers for conduct of election in a peaceful manner.

The Block Development Officers have been designated by the Commission as the Block Level Coordinating Officers who may be advised to supervise the different stages of the election process.

The Commission requests the Collectors to take the lead in the district and render necessary guidance and supervision for conduct of the poll in the district in a fair and peaceful manner.

Sub: Clarification on references made to Commission on conduct of Election.

Sir,

Some times references are received at Commission level seeking clarification as to which department will take up the conduct of election in respect of certain Co-operative Societies. I am directed to convey the view of the Commission as follows:

The superintendence, direction and control of the conduct of election vest with the State Co-operative Election Commission as per the provision of Section 28-AA of the OCS Act, 1962. The function of the Commission begins only when an intimation is received from the Chief Executive of the Society as provided Under Section 28-A(2)

of the OCS Act, 1962. It implies that the Chief Executive or Management In-charge has the responsibility of intimating the Commission to take up the process of election. Different types of Co-operative Societies are organized under the administrative control of different departments. So it is the responsibility of the concerned departments to ensure that the intimation with regard to conduct of election in respect of the societies coming under their jurisdiction are sent to the Commission in due time.

It is not under the purview of the Commission to ascertain as to which Society is coming under the administrative control of which department nor the Commission has got any authority to decide it. Government of Odisha in Cooperation Department have declared different Directors as Additional Registrar of Co-operative Societies and delegated them along with other subordinate officers various powers under different Sections of the OCS Act. The RCS has power of assigning the local limits to these officers. The clarification with regard to jurisdiction of departments in respect of Co-operative Societies can be clarified by the concerned authorities i.e. Government in Cooperation Department and Registrar of Co-operative Societies.

In case any dispute on the matter of deciding the jurisdiction of the department on a particular Co-operative Society as regards to conduct of election arises that has to be sorted out inter departmentally without making any reference to the Commission.

Therefore, necessary action may please be taken in this regard so that no Co-operative Society due for election is left out from the election process.
